Notice of forthcoming merger In Popůvky on: 15 December 2022

The legal effects of the merger are expected on <u>1 January 2023</u>.

As a result of the merger, the companies HUTIRA - VISION, s.r.o. and ATJ special, s.r.o. will be dissolved and all the assets of these two companies, <u>including the rights and obligations in relation to you</u>, will be transferred to the successor company HUTIRA - BRNO, s.r.o., which will continue the business activities of its legal predecessors after the completion of the merger process without any changes or interruptions. The aim of the described merger is only to simplify and clarify the organizational structure of the companies in the HUTIRA group, or more precisely to adjust the structure of the group's business in the Czech Republic.

Since HUTIRA - BRNO, s.r.o. will become the universal legal successor of HUTIRA - VISION, s.r.o. and ATJ special, s.r.o. as a result of the merger, all rights and obligations under the contracts concluded with you will automatically pass to the successor company with effect from the date of registration of the merger in the Commercial Register.

HUTIRA - BRNO, s.r.o. will change its name to HUTIRA s.r.o. as of 1 January 2023.
